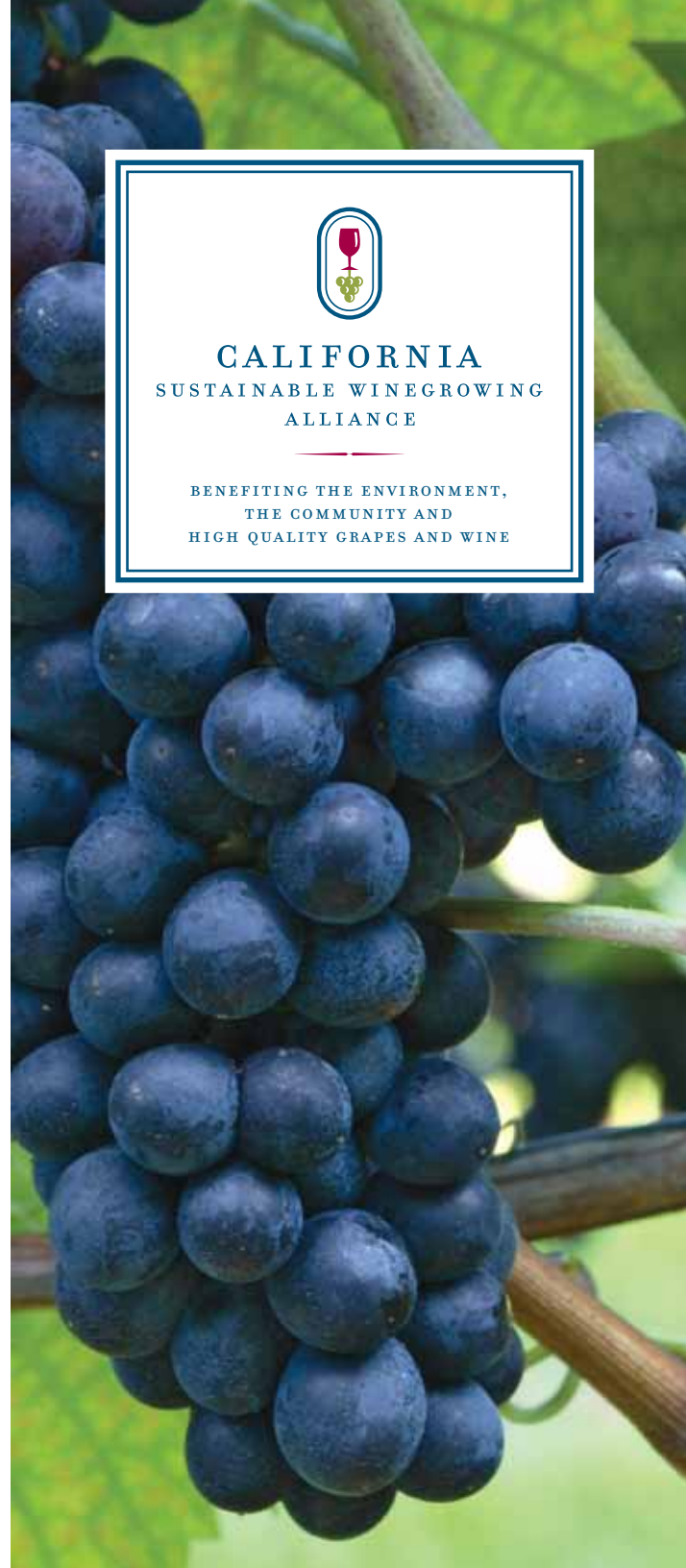

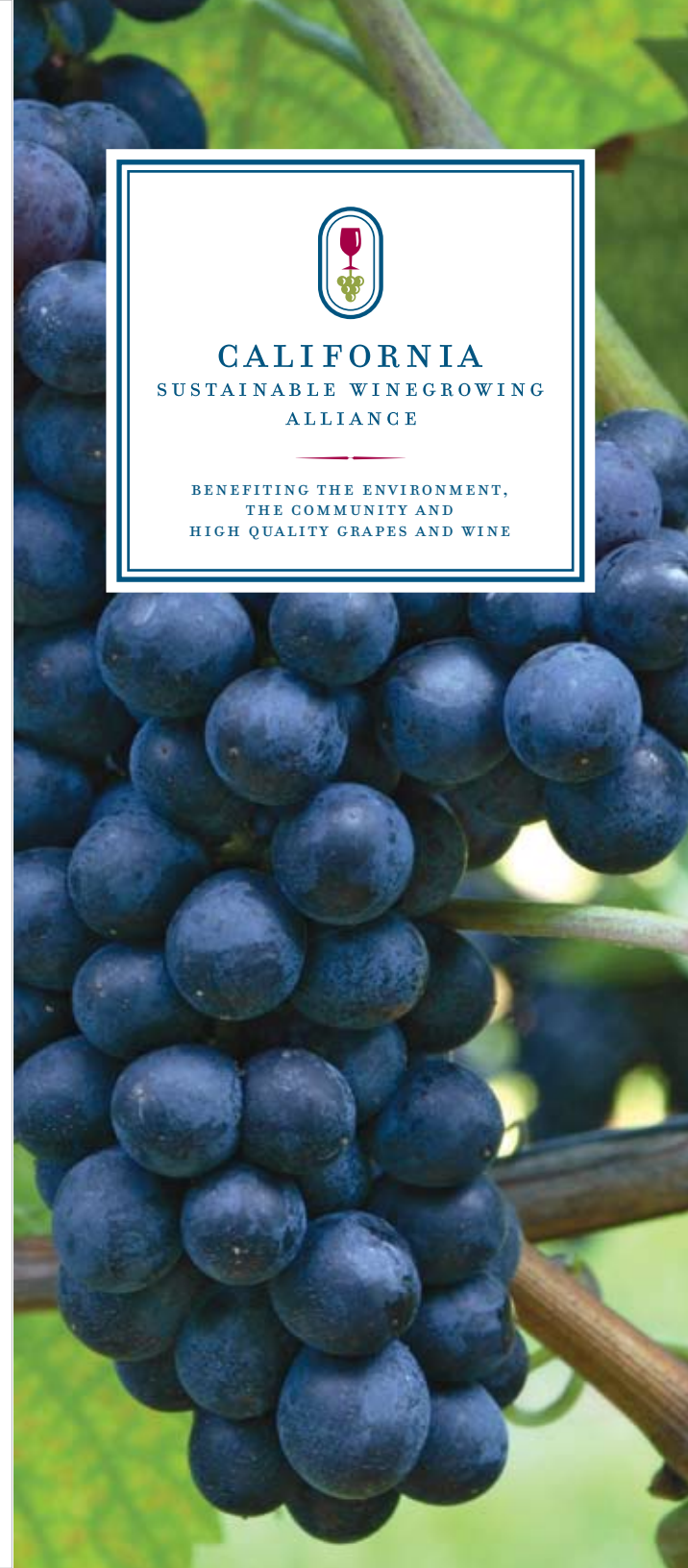

SUSTAINABLE WINEGROWING PRACTICES IN CALIFORNIA

To achieve sustainability and high quality grapes and wine, California wineries and vineyards use a continuous improvement approach involving hundreds of practices implemented over time to best serve the environment, employees, communities, and the vineyard or winery.

Sustainable winegrowing and winemaking includes:

- ☞ Managing vineyards for sustainability and quality fruit
- ☞ Conserving water and energy
- ☞ Protecting air and water quality
- ☞ Maintaining healthy soil
- ☞ Reducing pesticide use
- ☞ Preserving local ecosystems and wildlife habitats
- ☞ Recycling natural resources
- ☞ Practicing environmentally preferred purchasing
- ☞ Enhancing relations with employees and communities

THE CALIFORNIA SUSTAINABLE WINEGROWING PROGRAM

Created in 2002, the California Sustainable Winegrowing Program (SWP) is an educational program to help wineries and vineyards continuously improve in adopting and implementing sustainable practices. Soon after its launch, the program won the Governor’s Environmental and Economic Leadership Award among other awards.

The SWP provides vineyards and wineries with educational workshops and tools, including a self-assessment workbook covering 227 sustainable practices from grape to glass. To date, more than 1,500 growers and vintners representing 68% of California wine grape acreage and 62% of wine case production have evaluated their vineyards and wineries using the workbook. Results of self-assessments are collected and reported publicly on a continuous basis.

Introduced in 2010, Certified California Sustainable Winegrowing (CCSW-Certified) grew out of the SWP and provides third-party verification of a winery or vineyard’s adherence to a “process of continuous improvement” in adopting and implementing sustainable practices. Certification is a voluntary option; vintners/growers can still participate in the educational SWP to improve their practices and bottom lines.

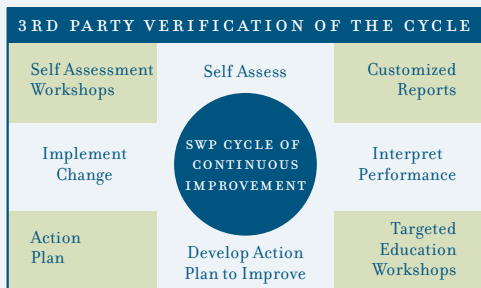

FREQUENTLY ASKED QUESTIONS:

WHAT IS CCSW-CERTIFIED?

CCSW-Certified is an acronym for Certified California Sustainable Winegrowing, a certification program developed by the California Sustainable Winegrowing Alliance (CSWA) that provides verification that a winery or vineyard adopts and implements sustainable winegrowing practices according to the industry's code of 227 best practices and commits to a "process of continuous improvement" in these practices. This approach provides the flexibility to address the most critical regional and organizational issues across diverse regions of California for both wineries and vineyards. After evaluating practices and meeting 58 prerequisite criteria, companies use self-assessment data to determine what areas need to be improved, focus their resources on practices that will make the most difference for their sustainability goals, and continually improve year after year to retain certification.



WHY DO CALIFORNIA'S GROWERS AND VINTNERS SEEK CCSW-CERTIFICATION?

Certification provides vineyards and wineries with a vehicle to communicate their high level of commitment to sustainability to public policy leaders, retailers, consumers and communities.

WHAT ARE THE GOALS OF CCSW?

The goals for Certified California Sustainable Winegrowing are to provide third party verification of the adherence to sustainable practices and continuous improvement goals for individual vineyards and wineries and to encourage statewide participation that advances the entire California wine industry toward best practices in environmental stewardship, conservation of natural resources and socially equitable business practices.

IS THERE NOW A NEW CATEGORY OF WINE CALLED "SUSTAINABLE WINE"?

At present, there is no legal term or official category for "sustainable wine." The sustainable certification program is focused on the winery and vineyard practices that impact land, resources and people, which is different than certifying the product in the bottle. In the interest of clearly and accurately presenting the program, CCSW-Certified does not attempt to create a definition for sustainable wine nor does it currently allow the use of a logo or certification claim on the bottle. Companies are referred to as a "CCSW-Certified winery" or "CCSW-Certified vineyard," accompanied by the name of the winery or vineyard operation that has been certified.
